

UNRIVALED ATHLETE AWARD

Please read the following carefully before submitting your nomination. You must check each box individually to confirm your separate acknowledgment and consent to each item. All boxes must be checked before your nomination can be submitted. 3. INDEMNIFICATION: I agree to indemnify and hold harmless the Released Parties from and against any and all claims, demands, liabilities, costs, and expenses (including reasonable attorneys' fees) arising out of or relating to any breach of my representations or warranties herein or arising out of the exercise of the rights granted above. I acknowledge that the Released Parties are under no obligation to exercise any rights granted herein.

4. VERIFIABLE PARENTAL CONSENT (COPPA): I acknowledge that the nominated Athlete is under 13 years of age and that my completion of this form constitutes verifiable parental consent as required under the Children's Online Privacy Protection Act (COPPA). I understand that Unrivaled Sports may not collect, use, or display the athlete's personal information, image, or voice recordings without this consent, and that the nomination cannot be processed without it.
